**AN ORDINANCE** appropriating \$20,000.00 from the fund balance of the 2010 Anti-Drug Sales Tax Fund to the Jackson County Family Court Division to provide supplemental funding for the Family Court Division's Night Light program.

INTRODUCED BY Dan Tarwater, County Legislator

WHEREAS, the Family Court Division Night Light program provides evening and late night supervision to juvenile offenders who are determined to be at high risk of re-offending; and,

WHEREAS, by Resolution 17140, dated January 19, 2010, the County Legislature authorized the use of 2010 Anti-Drug Sales Tax funds to supplement the Night Light program; and,

WHEREAS, while Resolution 17140 authorized a contract with the Family Court Division, all that is necessary to implement this program is an appropriation to place the funds in the proper spending accounts; and,

WHEREAS, the County Executive recommends said appropriation; now therefore,

BE IT ORDAINED by the County Legislature of Jackson County, Missouri, that the following appropriation be and hereby is made:
