Other founding members are the Cities of Grandview, Lee's Summit, Raytown, Independence, Blue Springs, Grain Valley, and Oak Grove.</p> <p>The Department of Economic Development presents the attached Memorandum of Understanding which sets out the rights and obligations of each participating partner in the EJCDA and authorizes the payment for annual membership dues in the Alliance in the amount of \$11,000.00 for 2015, with funds for future years subject to appropriation in the then current Jackson County budget.</p>
