REQUEST SUMMARY	Jackson County entered into an agreement with Modot to make improvements to H highway and Pink Hill/Renick Roads. The agreement allows Modot to work on County right of ways per the plans to accomplish the design and construction needed. Modot now would like Jackson County to donate approximately 6838 s.f. of right of way to Modot at the intersection. This right of way would give Modot better control of the intersection such as traffic control devises, or utility uses in the intersection, and maintain continuity with the new right of way takings adjacent to this taking. The original agreement still remains in effect until the project is completed. The Public Works Department has reviewed the request and recommends the County Executive be authorized to execute the deed on behalf of Jackson County.
