TITLE: Awarding a split contract for a Twenty-four (24) Month Term and Supply Contract with One (1) Twelve Month Option to Extend for the furnishing of County Vehicle Maintenance and Repair Services for use by various County Departments to Bird Automotive of Blue Springs, Missouri, Glenn's Tire and Automotive, Inc of Independence, Missouri, Metro Ford, Inc of Independence, Missouri and Take 5 Oil Change of Charlotte, North Carolina under the terms and conditions of Invitation to Bid No. 26-040.

SUMMARY: Various County Departments require a Term and Supply Contract for the furnishing of Vehicle Maintenance and Repair Services. The Purchasing Department issued Invitation to Bid No. 26-040 in response to those requirements. A total of 211 notifications were distributed, fifty-six (56) document takers with seven (8) responses received and evaluated: Bird Automotive of Blue Springs Clarke Power Services Glenn's Tire and Automotive, Inc Metro Ford, Inc Mico Transportation and Repair Take 5 Oil Change V&V Business Solutions Julian Caesar (eliminated) An Executive Summary of the Invitation to Bid and the using departments Recommendation Memos are attached.

Pursuant to Section 1054.6 of the Jackson County Code, the Purchasing Department recommends a split award of a Twenty-four (24) Month Term and Supply Contract with One (1) Twelve Month Option to Extend for the furnishing of County Vehicle Maintenance and Repair Services for use by various County Departments to Bird Automotive of Blue Springs, Missouri, Glenn's Tire and Automotive, Inc of Independence, Missouri, Metro Ford, Inc of Independence, Missouri and Take 5 Oil Change of Charlotte, North Carolina under the terms and conditions of Invitation to Bid No. 26-040 as the best qualified bids received. A split award is recommended for this service to offer easily located and multiple options to various County Department locations. County departments state annually estimated usage of \$641,000. The award is made on an "as needed" basis and does not obligate Jackson County to pay any specific amount. The availability of funds for specific purchases is subject to annual appropriations.
