AN ORDINANCE appropriating \$12,700.00 from the undesignated fund balance of the 2022 Grant Fund and authorizing the County Executive to execute a cost-share agreement for the Missouri Department of Conservation's Tree Resource Improvement and Maintenance Program.

WHEREAS, Jackson County Parks + Rec applied for a grant and received a notice of award in the amount of \$12,700.00 under the Missouri Department of Conservation's Tree Resource Improvement and Maintenance (TRIM) Program; and,

WHEREAS, the funds will be utilized to remove infected ash trees in the park system that have been impacted by the emerald ash borer; and,

WHEREAS, this grant is subject to a 100% local match; and,

WHEREAS, the attached Agreement provides a suitable mechanism by which to implement the County's participation in the plan; and,

WHEREAS, an existing County term and supply vendor will be utilized to complete the work in connection with this grant; and,

WHEREAS, an appropriation is necessary to place the funds needed for this program in the proper spending account; now therefore,

BE IT ORDAINED by the County Legislature of Jackson County, Missouri, that the following transfer within the 2022 General Fund be and hereby is made:


