### TERMS AND CONDITIONS GOVERNING ARTWORK LOAN AGREEMENT

- 1. The Lender certifies that the Artwork being lent identified on the Artwork Loan Agreement attached hereto and incorporated herein is in excellent condition, requiring no repairs or cleaning in preparation for exhibition and is in a "ready to hang" condition.
- 2. Except as set forth by Lender above, Lender warrants that he has all right, title and ownership interest in the Artwork, and that the Artwork is not subject to any ownership, lien, encumbrance, copyright infringement or other claim by any other person or entity.
- 3. Packing and shipping charges, insurance costs, other handling expenses, and risk of loss or damage incurred in the delivery of Artwork from the Lender to the Museum are the responsibility of Lender. Packing and shipping charges, insurance costs, other handling expenses, and risk of loss or damage incurred in the delivery of Artwork from the Museum to the Lender shall be the responsibility of the Lender.
- 4. The Artwork shall remain in the possession of the Museum for which it has been borrowed, for the time specified in this Agreement, but may be withdrawn from exhibition at any time by the Museum or Lender. The Artwork will be returned only to the Lender at the address shown in this Agreement unless the Museum is notified in writing.
- 5. Museum shall insure the Artwork in its possession against "all risks" of physical loss or damage from any external cause while on location at the Museum during the period of this loan.
- 6. Except in case of emergency to preserve the Artwork, the work of art will not be cleaned, restored, or otherwise altered without the written consent of the Lender except in an emergency, in which case the Lender will be notified by telephone and in writing.
- 7. This Agreement shall be governed and construed under the laws of the State of Missouri, which shall also be the forum for any litigation arising from or incident to this Agreement. This Agreement may not be assigned by either party without the express written consent of the other, in advance.

- 8. This Agreement and attachments referenced herein, if any, constitute the entire understanding between the parties with respect to the subject matter hereof and may be amended at any time only upon mutual written agreement of the parties. Any notice to the other party shall be sent to either party at the addresses set forth above by registered or certified mail, return receipt requested or overnight mail service, with proof of delivery.
  - 9. Either party may terminate this Agreement by giving the other party 30 days written notice.

# **OUTGOING LOAN CONDITIONS**

### CARE AND PROTECTION

Objects borrowed shall be given special care at all times to insure against loss, damage, or deterioration. The borrower agrees to meet any special requirements for installation and handling as noted and referenced on the face of this agreement. Only experienced personnel will handled the objects. Objects must be protected from extreme temperatures and humidity, excessive light and from insects, vermin, dirt or other environmental hazards. Objects will be secured from damage and theft by appropriate barriers, and they will be displayed with maximum attention to security. Objects will be maintained in a building equipped to protect them from fire, smoke and flood damage. They will be under 24-hour physical or electronic security. The SHS certifies that the objects lent are in such condition as to withstand ordinary strains of packing, transportation and handling. The SHS may provide a condition report made just prior to packing. The borrower is advised to make a written condition report upon arrival and return of the object. The SHS may require an on-site inspection and approval of the actual installation by a member of its own staff at the expense of the borrower. With the exception of agreed upon installation and deinstallation movements, SHS will be notified immediately if object(s) are removed from approved exhibition or storage sites for any reason, and SHS may require immediate return of the loan at the borrower's expense or immediate inspection of new/alternate storage of display sites. If object(s) are lost or damaged in any way, SHS will receive immediate notification, followed by a report, if damage or loss is discovered. A damaged object will not be shipped without SHS approval. If damage occurred in transit, the borrower will also notify the carrier and save all packing and materials for inspection. No object may be altered, cleaned, repaired or furnigated without written permission of the SHS; nor any framing, matting, mounting or glazing be changed without written permission; nor may objects be exa

## PACKING AND TRANSPORTATION

The SHS will specify the method for packing and will provide any special instructions for unpacking and repacking. Objects will be returned packed in the same or similar materials by experienced personnel. Crates and packing materials will be stored during the loan period in a place conditioned to the same temperature and relative humidity levels as those under which the object itself is stored or displayed. The loan will arrive and be returned in the manner of shipment mutually agreed upon by the borrower and the SHS. Only approved fine art handlers may transport the objects. Sufficient notice should be given to the SHS for the intended date of collection and for the date of return. A SHS courier may be required for any leg of the journey. The SHS may request the air-freight shipments be observed when loading for the return shipment. Objects transported by truck must be accompanied by two persons, and the vehicle must never be left unattended. Arrangements must be made for vehicle security if overnight stops are necessary.

#### INSURANCE

Objects shall be insured during the period of this loan for the value stated on the face of this agreement under an 'all-risk,' wall-to-wall policy subject to the following standard exclusions: wear and tear, gradual deterioration, insects, vermin or inherent vice, repairing, restoration or retouching processes; hostile or warlike action, insurrection, rebellion, nuclear reaction, nuclear radiation, or radioactive contamination. SHS may request a certificate of insurance or a copy of the policy made out in favor of the SHS prior to the shipment of the objects. The SHS must be notified in writing at least 20 days prior to any cancellation or meaningful change in the borrower's policy. Any lapses in coverage, any failure to secure insurance and/or inaction by the SHS regarding notice will not release the borrower from liability for loss or damage. Insurance value may be reviewed periodically, and the SHS reserves the right to increase coverage if reasonably justified. In the event of loss or damage, the borrower's maximum liability will be limited to the insurance value then in effect. If insurance is waived, the borrower agrees to indemnify the SHS for any loss or damage to the objects occurring during the course of the loan, except for loss or damage resulting from wear and tear, gradual deterioration, inherent vice, war and nuclear risk.

## REPRODUCTION AND CREDIT

The SHS will make available photographs of objects lent, which may be used for catalog, routine non-commercial educational uses, publicity, and registrarial purposes. No further use of such photographs can be made, and no other reproduction of objects lent can be made without written permission of the SHS director. If photographs are not available, the borrower may seek permission from SHS to make necessary photographs. Each object will be labeled and credited to the SHS.

#### **COSTS**

Unless otherwise stated on the front of this contract, all costs of packing, transportation, couriers, insurance and other loan-related expenses will be borne by the borrower. The estimated costs must be agreed on by both parties.

# CANCELLATION/RETURN/EXTENSION

The SHS reserves the right to recall the objects from loan or cancel the loan for good cause at any time, and will make every effort to give reasonable notice thereof. Objects lent must be returned to the SHS by the stated return date. Any extension of the loan period must be approved in writing by the SHS director or his designate and covered by written parallel extension of the insurance coverage.

## INTERPRETATION

In the event of any conflict between this agreement and any forms of the borrower, the terms of this agreement shall be controlling. For loans to borrowers outside the United States, this agreement shall be construed in accordance with the law of the State of Missouri.
