WHEREAS, the Jackson County Parks + Rec has been awarded a grant from the Andrew W. Mellon Foundation as part of the Kansas City Monuments Coalition program in the amount of \$108,000.00, to provide funding for improvements to make the Fort Osage National Historic Landmark ADA compliant; and,

WHEREAS, the grant is awarded for the period of January 1, 2025, through January 15, 2026; and,

WHEREAS, an appropriation is necessary to place the grant funds in the appropriate spending accounts; now therefore,
