SUMMARY: Various County Departments require a Term and Supply Contract for the furnishing of miscellaneous Plumbing Services. The Purchasing Department issued Invitation to Bid No. 24-044 in response to those requirements. A total of 231 notifications were distributed, nineteen (19) document takers with three (3) responses received and evaluated. An Executive Summary of the Invitation to Bid, including the Contractor's Quotations and the using departments Recommendation Memos are attached. Pursuant to Section 1054.6 of the Jackson County Code, the Purchasing Department recommends a split award of a Twenty-Four (24) Month Term and Supply Contract with One (1) Twelve Month Option to Extend for the furnishing of miscellaneous Plumbing Services for use by various County Departments to U.S. Engineering Service, LLC, Rand Construction Company and Emcor Services Fagan all of Kansas City, Missouri under the terms and conditions of Invitation to Bid No. 24-044 as the best qualified bids received. A split award is being recommended for miscellaneous Plumbing Services so ensure
