

ADDENDUM TO  
COOPERATIVE AGREEMENT

**THIS ADDENDUM TO AGREEMENT**, made by and between **JACKSON COUNTY, MISSOURI**, a Constitutional Home Rule Charter County of the First Class of the State of Missouri, hereinafter referred to as "the County" and a Missouri not-for-profit corporation, **ONE GOOD MEAL, PO BOX 2222, LEE'S SUMMIT, MO 64063**, hereinafter referred to as "Organization".

WHEREAS, pursuant to the Resolution 19682, dated December 28, 2017, the County did enter into a Cooperative Agreement with Organization dated July 5, 2018, whereunder the Organization agreed to provide certain public health related services to County residents, at a cost to the County, not to exceed \$30,000; and

WHEREAS, the parties now desire to provide for an increase in the scope of services provided by Organization, at an additional cost to the County not to exceed \$20,000; and

WHEREAS, the County deems it to be in the best interests of its citizenry to further support Organization's programs and activities; and

NOW THEREFORE, in consideration of the foregoing and the terms and provisions herein contained, the County and Organization respectively promise, covenant, and agree with each other as follows:

**NOW, THEREFORE**, it is agreed by and between the parties as follows:

1. Except as specifically provided herein, the Cooperative Agreement of the parties dated July 5, 2018, shall remain in full force and effect pursuant to its terms; and

2. The County shall pay Organization the additional ~~sum~~ of \$20,000 for

Organization's additional services in accordance with Exhibit A to the original Cooperative Agreement. The payments for the third and fourth quarters specified in the original Agreement shall be increased to the sum of \$17,500 each upon receipt of all reports due for the prior quarters; and

3. This Agreement, together with the originals Cooperative Agreement dated July 5, 2018, incorporates the entire understanding and agreement of the parties.

WORK AUTHORIZATION AFFIDAVIT

As a condition for any service provided to the County, a business entity shall, by sworn affidavit and provision of documentation, affirm its enrollment and participation in a federal work authorization program with respect to the employees working in connection with the contracted services.

Business entity, as defined in section 285.525, RSMo pertaining to section 285.530, RSMo, is any person or group of persons performing or engaging in any activity, enterprise, profession, or occupation for gain, benefit, advantage, or livelihood. The term "business entity" shall include but not be limited to self-employed individuals, partnerships, corporations, contractors, and subcontractors. The term "business entity" shall include any business entity that possesses a business permit, license, or tax certificate issued by the state, any business entity that is exempt by law from obtaining such a business permit, and any business entity that is operating unlawfully without such a business permit.

Every such business entity shall complete the following affidavit affirming that it does not knowingly employ any person who is an unauthorized alien in connection with the contracted services. The completed affidavit must be returned as a part of the contract documentation.

This affidavit affirms that **ONE GOOD MEAL**, is enrolled in, and is currently participating in, E-verify or any other equivalent electronic verification of work authorization operated by the United States Department of Homeland Security under the Immigration Reform and Control Act of 1986 (IRCA); and, **ONE GOOD MEAL**, does not knowingly employ any person who is an unauthorized alien in conjunction with the contracted services.

In Affirmation thereof, the facts stated above are true and correct. (The undersigned understands that false statements made in this filing are subject to the penalties provided under section 575.040, RSMo.)
