A RESOLUTION declaring certain County-owned boats as surplus property and authorizing their disposal pursuant to Chapter 11 of Jackson County Code, 1984.

RESOLUTION NO. 22003, August 18, 2025

INTRODUCED BY Megan L. Smith, County Legislator

WHEREAS, the Jackson County Parks + Rec have boats that are no longer in use, inoperable, or unable to be repaired and therefore needs to be declared surplus in order to be sold or disposed of pursuant to Chapter 11, Jackson County Code, 1984; and,

WHEREAS, by Resolution No. 21597, dated April 15, 2024, the Legislature did authorize auction services for the sale of County owned property and equipment to Purple Wave of Manhattan, KS; and,

WHEREAS, the Director of Finance and Purchasing recommends that the County-owned boats listed on the attached declaration and transfer form be declared surplus and unusable and disposed of via auction by Purple Wave pursuant to section 1131.1 of the Jackson County Code, 1984; and,

WHEREAS, the Director of Parks + Rec has requested, and the Director of Finance and Purchasing recommends that the boats listed on the attached form declared unusable shall be declared surplus and disposed of pursuant to section 1141. of the Code; now therefore,

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
