TO THE JACKSON COUNTY LEGISLATURE:

Today I have signed Ordinance 5354, which appropriates \$27,039,000 from the undesignated fund balance of the 2020 CARES Act Fund for the use and benefit of Truman Medical Centers (TMC).

I am signing Ordinance 5354 due to the urgent COVID-19 related needs in our community and TMC's essential role in Jackson County's response. However, I am doing so with significant hesitation and concern regarding the way the Ordinance was passed.

Specifically, prior to the passage of this Ordinance, the County Counselor warned that "the County Legislature is without authority at this time to appropriate any new revenues for these purposes." Subsequently, at my request, the County Counselor provided additional information regarding the legality of the Ordinance and stated, in part, the following:

"I shall not here attempt to address the legal status of Ordinance 5354 as things stand now but, suffice it to say, that status at this point is murky at best. In view of this status, I believe that the most prudent course of action to follow in order to implement the intent of Ordinance 5354 would be for you to formalize your proposal of additional revenue, as required by code section 532, 1, and then recommend that the legislature introduce a new ordinance, in a proper form which I would approve, and adopt that new ordinance. This process would resolve any issues created by the adoption of Ordinance 5354." ii

You have asked for guidance from this office as to any legal issues associated with the recent adoption of Ordinance 5354 by the Jackson County Legislature. This ordinance, a copy of which is attached as Exhibit A., was introduced and purportedly adopted by the legislature on June 3, 2020. On its face, this ordinance appropriates \$27,039,000 in CARES Act funding for use by Truman Medical Centers, Inc. (TMC), in the current coronavirus pandemic. This ordinance was not approved as to form by this office, as is required by article V, section 7 of the Jackson County Charter. Nor does it bear the revenue certificate/fiscal note signed by the budget officer, required by section 50.660, RSMo. This approval and revenue certificate are missing because, as I stated in my memorandum of June 2, 2020, attached to Ordinance 5354 and included in Exhibit A, this ordinance would appropriate new revenues outside of Jackson County's annual budget process, in contravention of section 532 of the Jackson County Code, in that the county executive, has not "proposed any additional expenditures" for TMC, such as would be authorized by the ordinance, even though such a proposal of additional expenditures is a specific requirement of section 532.1 of the county code.

You have indicated your intent to authorize the funding of TMC provided for in Ordinance 5354, but have also expressed concern about whether the manner in which the ordinance was adopted might have negative legal repercussions in the future. I shall not here attempt to address the legal status of Ordinance 5354 as things stand now but, suffice it to say, that status at this point is murky at best. In view of this status, I believe that the most prudent course of action to follow in order to implement the intent of Ordinance 5354 would be for you to formalize your proposal of additional revenue, as required by code section 532,1, and then recommend that the legislature introduce a new ordinance, in a proper form which I would approve, and adopt that new ordinance. This process would resolve any issues created by the adoption of Ordinance 5354.

You have also asked whether, based on the information available today, the items which would be funded for TMC by Ordinance 5354, are eligible for funding under the Coronavirus Aid, Relief, and Economic Security (CARES) Act. Section 601(d) of the Act restricts the use of CARES Act funds to those that:

- (1) are necessary expenditures incurred due to the public health emergency with respect to the Coronavirus Disease (COVID-19);
- (2) were not accounted for in the budget most recently approved as of the date of enactment of this section for the State or government; and
- (3) were incurred during the period that begins on March 1, 2020, and ends on December 30, 2020.

I don't believe there's any issue that the funds appropriated by Ordinance 5354 were not included in Jackson County's 2020 budget. Likewise, it seems fairly clear that the expenditures proposed are for the time period specified in subsection 3 above. The real issue is whether the proposed expenditures would be "incurred due to the public health emergency with respect to the Coronavirus Disease (COVID-19)." Attached to this memorandum as Exhibit B is a document that was distributed in some manner at the legislature's meeting of June 3, 2020, in connection with the adoption of Ordinance 5354. It shows in summary fashion thirteen proposed expenditures of CARES Act funds by TMC, which total \$27,039,000, the same amount as was appropriated by Ordinance 5354. Thus, it appears that Exhibit B sets out the proposed expenditures for the appropriated funds. But there is practically no detail here that will allow us to evaluate whether these are "necessary" expenditures "due to the public health emergency." I recommend that county staff contact TMC representatives and ask them to prepare a brief (less that five-page) summary document, explaining these proposed expenditures and how they're necessary due to the public health emergency. We can then review that response and make a determination. Regarding proposed contractual language to protect the county in the event the TMC makes inappropriate expenditures. the legislature has recently authorized the retention of attorney Travis Elliott of Springfield, MO, to assist us with contract drafting. We plan to speak with him later today. We'll work with Mr. Elliott to make develop the guidance you've requested.

WHEREAS, U.S. President Donald J. Trump, Missouri Governor Mike Parson, and County Executive Frank White, Jr., have all declared, in one form or another, the ongoing Coronavirus/COVID-19 pandemic to be a public health emergency; and,

WHEREAS, the County, through its various efforts, plays a significant role in the public health of its citizens; and,

WHEREAS, an appropriate response by the County to this emergency will require significant expenditures from the County CARES Act Fund, which consists of monies provided by the U.S. Treasury for this purpose; and,

WHEREAS, with the funding provided by this appropriation, Truman Medical Centers will make critical facility improvements and acquire needed equipment to better prepare for current and future pandemic response; now therefore,

BE IT ORDAINED by the County Legislature of Jackson County, Missouri, that the following appropriation be and hereby is made:

You have asked this office to provide guidance on the interplay between section 532 of the Jackson County Code and the recent midyear receipt of significant federal funding via the Coronavirus Aid, Relief, and Economic Security (CARES) Act of 2020. Per that Act, and pursuant to an application for direct federal funding that you filed with the U.S Treasury as authorized by the Act, Jackson County has received \$122,669,998.00 for coronavirus pandemic relief, of which \$18,354,806.00 has been previously appropriated by the County Legislature at your recommendation.

Section 532., Jackson County Code, 1984, provides:

532. Appropriations, Limitation on.

The County Legislature shall not increase the total appropriation from any fund as proposed by the County Executive in the budget so that the total appropriations shall exceed ninety-five percent (95%) of the income and revenue as estimated by the County Executive in the budget.

532.1 Exception, New Revenue.

If the County Executive shall propose and the County Legislature shall enact a measure that will provide additional income and revenues, and if the County Executive shall propose additional expenditures, the County Legislature may appropriate an amount equal to not more than ninety-five percent (95%) of the estimated income and revenue from the new source or sources.

This section governs how the County is to treat new revenues that are received midyear and that are not a part of the County's annual budget process. Since the CARES Act funding received is not included in the 2020 Jackson County budget, the first paragraph of section 532, which governs the County Legislature's power to appropriate funds that you estimated in the annual budget, does not apply. Rather, the appropriation of CARES Act funds is governed by the exception in section 532.1. The County Legislature may

appropriate up to 95% of this "additional income and revenues" only if "the County Executive shall propose additional expenditures."

Regarding pending legislative items, you have advised that you have not proposed any expenditures of CARES Act funds for hazard pay for County associates as contemplated by Ordinance 5352 now pending before the Legislature. You have also advised that you have not proposed any expenditure for Truman Medical Centers, Inc., for building improvements or equipment. Accordingly, the County Legislature is without authority at this time to appropriate any new revenues for these purposes.
