SUBJECT: Request approval to utilize another government contract

Ms. Casamento,

I previously submitted a memorandum requesting permission to use the contract of the Independence Missouri Police Department reference the purchase of KDH Systems ballistic vests from their service provider 911 Custom of 6970 West 152nd Terrace Overland Park, Kansas 66223 for use by the Jackson County Sheriff's Office.

Earlier this year, Colonel Hugh Mills and his training staff conducted an extensive review of ballistic vest providers and determined KDH Systems ballistic vests met the needs of our agency. KDH Systems submitted a GSA contract and the Sheriff's Office received approval to purchase vests from them reference the contract. It should be noted that KDH Systems utilizes 911 Custom as their local authorized dealer and they are currently a vendor with a government contract in place with the Independence Police Department.

KDH Systems sent a copy of a GSA contract to purchasing, and their contact, Julie Kiselica, made contact with your office to address additional issues with the contract. Since that time we have found, by talking to KDH customer service and our current vendor for emergency equipment, 911 Custom, that KDH Systems does not sell directly to end users and only authorized vendors may place orders and issue invoices for orders.

Because of the above listed reasons, in addition to our immediate need to obtain replacement ballistic vests for members of our agency, I request that we be allowed to utilize the contract between KDH systems and the City of Independence Missouri, which specifies that 911 Custom be the vendor for KDH ballistic vests.
