I am looking forward to the challenge of a new workplace. My objective is to establish a longstanding positive relationship with the taxpayers in Jackson County. The taxpayers need to feel that they have taxation with representation.

WORK HISTORY

Cass County Assessor, Cass County, Harrisonville, Missouri 64701 November 1996 to present

I was elected to the office of Cass County Assessor in November of 1996. The assessed value in 1996, when I was elected, was 533,000,000 and is now in 2007, 1,300,000,000. My first year in office, we put on 256 new homes. That amount increased every year until 2004, when we peaked and put on 4400 new homes in 2004. I am solely responsible for the funding and creating of the Cass County GIS System. I personally attended city council meetings at five different municipalities and was able to prove the need for GIS, which convinced them to fund half of the county GIS project. During my tenure as Assessor, Cass County has never been out of assessment ratio tolerance with the State Tax Commission. I have been responsible for writing and implementing five county Assessment Maintenance Plans, which have all been approved by the State Tax Commission. I lobbied successfully in 2003 to have Cass County added to a legislative bill in committee that resulted in Cass County receiving over \$400,000 additional dollars, annually, to run the office. This change made in committee at my request only affected Cass County. I have created several assessments of Tax Increment Finance (TIF) Districts, Chapter 100 Districts, and 353 Districts. I am responsible for the assessment of several school districts and other taxing entities that overlap into both Cass County and Jackson County.
