WHEREAS, by Resolution 15511, dated June 6, 2005, the Legislature did authorized the execution of a Memorandum of Understanding (MOU) with Local Union No. 42 of the International Association of Fire Fighters (the Union) to govern the terms and conditions of employment of members of its bargaining unit within the Prosecuting Attorney's Office through December 31, 2008; and,

WHEREAS, in anticipation of the expiration of the MOU, the parties have commenced negotiations with the goal of reaching agreement on a successor MOU; and,

WHEREAS, in view of the pending negotiations, and in anticipation of arriving at a successor MOU, the parties have agreed that it is appropriate to extend the terms of the prior MOU, save that governing compensation, through March 15, 2009; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the County Executive be and hereby is authorized to execute the attached Agreement to Extend MOU with Local Union No. 42 of the International Association of Fire Fighters, for a period ending March 15, 2009.

AGREEMENT TO EXTEND MOU

Article XXV, Section 1 of the current Memorandum of Understanding (MOU) between Jackson County, Missouri (the County) and Local No. 42 of the International Association of Fire Fighters (Local 42) provides that the MOU will remain in full force and effect until December 31, 2008.

The County and Local 42 hereby agree to extend the current MOU, except for the Article XVIII provisions related to Annual Compensation, until March 15, 2009, during which time the County and Local 42 will negotiate in good faith in an effort to reach a new agreement. The effective date of such extension shall be January 1, 2009. In the event that the parties reach a new agreement, the provisions of such agreement will be retroactive to January 1, 2009.
