**A TERM AND SUPPLY CONTRACT
Mortuary Services**

A Contract, by and between **JACKSON COUNTY, MISSOURI**, hereinafter called "the County," and **SLIDER FUNERAL HOME, INC.**, 1734 Washington Blvd., Kansas City, KS 66102, hereinafter called "Slider".

WHEREAS, pursuant to RSMo 205.630 the county is required to provide a reasonable sum, as determined by the county, to cover the funeral expense of individuals who die within the county and have no means of paying a funeral expense; and,

WHEREAS, the Director of Finance and Purchasing has solicited bids on Request for Proposal (RFP) No. 6-09 for the furnishing of professional mortuary services; and,

WHEREAS, by Resolution No. 17279, dated May 20, 2010, the legislature did award a 12-month term and supply contract for professional mortuary services under the terms and conditions of RFP No. 6-09;

NOW THEREFORE, in consideration of the foregoing and the terms and provision herein contained, County and Slider respectively promise, covenant and agree with each other as follows:

1. This Contract shall be binding when it is signed by the County's Director of Finance and Purchasing and shall run from June 28, 2010 until the end of the 12th consecutive month from the month during which it first took effect unless it is sooner terminated in accord herewith.

2. Slider shall provide burial services as set forth in RFP No. 6-09, attached hereto as Exhibit A and incorporated herein by reference.

3. The County shall pay Slider for services rendered under this Contract at the rate of \$1,135.00 for each burial, including casket, cemetery plot, and all related costs, as set forth in Exhibit A to the extent the terms of such papers were expressly or impliedly accepted by the County, or were modified in writing with the express or implied consent of the parties.

4. All modifications to this Contract must be in writing signed by the County's Director of Finance and Purchasing.

5. The laws of the State of Missouri and Jackson County, Missouri govern this Contract.

6. This Contract shall be binding upon and to the benefit of the successor and assignees of the parties.

7. Slider is an independent contractor and shall defend, indemnify and hold harmless the County for loss, damage or liability relating to this contract to the extent that such loss, damage, or liability results from the negligence or misconduct of Slider Funeral Home or its employees, agents or subcontractor.

8. The County reserves the right to terminate this Contract for any reason upon at least **14** days written notice to Slider Funeral Home.



The County will make a good faith effort to make payment within thirty (30) days after the date when a correct and complete invoice showing the pertinent County Purchase Order Number(s) is received from Slider. Payment may be withheld by the County to protect itself from actual or potential loss which has resulted or may result from the Slider's non-performance of any of its duties required hereunder.

10. Slider warrants that no officer or employee of the County, whether elected or appointed, shall in any manner whatsoever be interested in or receive any benefit from the profits or emoluments of this contract.


11. This Agreement incorporates the entire understanding and agreement of the parties.





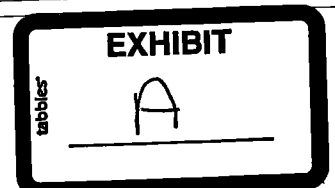

2.1 SUMMARY OF PROPOSED WORK

Slider Funeral Home will provide mortuary services for all Category I bodies at the request of the Medical Examiner, when the decedent's body is unclaimed or after it has been determined that the decedent has no family or concerned party willing to take financial responsibility for the burial or cremation and shall provide removal of decedent's remains and, upon referral by the county, for all Category II bodies, who died in Jackson County, Missouri after it has been ascertained that the decedent has no family or concerned party willing to take financial responsibility for the burial or other disposition of the decedent. It should be noted that Category I bodies will generally require disposition by cremation with a marker or burial and Category II bodies will generally require disposition by cremation and may include the involvement of family members or other concerned persons in the actual disposition. Attachment 5 contains our proposed and detailed list exceptions to the scope of work.


