WHEREAS, a service agreement is necessary to ensure the maintenance of the machines and continued effective security screening and inspections at courthouse entrances, as a sole source; and,

WHEREAS, pursuant to section 1030.1 of the Jackson County Code, the Director of Finance and Purchasing recommends the award of an annual service agreement for x-ray screening equipment for use by the Sheriff's Office to Smiths Detection, Inc., of Edgewood, Maryland at an actual cost to the County in the amount of \$36,564.00 as a sole source purchase; now therefore,
