INTRODUCED BY Bob Spence, County Legislator

WHEREAS, the City of Lee's Summit, MO, is widening Strother Road from I-470 west to Lee's Summit Road; and,

WHEREAS, the alignment of the new road crosses through County property at the Hilltop Home and the City of Lee's Summit requests the conveyance of the affected County property for this road project; and,

WHEREAS, these improvements to Strother Road are in the best interest of the health, safety, and welfare of the citizens of Jackson County; and,

WHEREAS, the Director of the Department of Public Works recommends execution of the right-of-way and easements upon the specified terms; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the County Executive be and hereby is authorized to execute the attached Right-of-Way, Permanent Drainage Easement, and Temporary Construction Easement, and any other related


documents necessary to convey the specified property to the City of Lee's Summit, MO, in a form to be approved by the County Counselor.





REQUEST SUMMARY	<p>The City of Lee's Summit is improving Strother Road from about I-470 west to Lee's Summit Road. The City has worked with JC Public Works Staff to design the new roadway alignment to cross County property in the most advantageous location for the future use of the affected property. The alignment crosses thru County property a lot depth away from the south property line, giving the county double frontage. The new Strother Road project will be two lanes with shoulders. As the existing road is very narrow, this will enhance the use of County properties and improve safety for the traveling public. The project is scheduled to begin in 2012/2013. The City has requested that the County donate the land rights needed for the project. The Public Works Department recommends the donation of the requested tracts and requests that a resolution be prepared authorizing the County Executive to sign conveyance documents.</p>

WITNESSETH, that the **Grantor**, in consideration of the sum of One Dollar (\$1.00) and other good and valuable consideration to it paid by the **Grantee**, the receipt and sufficiency of which is hereby acknowledged, does by these presents grant, bargain, sell, convey, and confirm unto said **Grantee**, its successors and assigns, a Right of Way easement for the construction, improvement, reconstruction and maintenance of a right of way for public use as a street, roadway or thoroughfare, including without limitation, the use of conduits, water, gas, sewer pipes, poles, wires, surface drainage facilities, ducts, cables on, over, along, across, and under the following described lots, tracts, or parcels of land lying, being and situated in the County of Jackson, and the State of Missouri, to-wit:
