SECOND ADDENDUM TO AGREEMENT
(Employment Barriers Program)

THIS SECOND ADDENDUM made this 1st day of November, 2017, by and between **JACKSON COUNTY, MISSOURI**, hereinafter called "the County" and a Missouri not-for-profit corporation, **TWELFTH STREET HERITAGE DEVELOPMENT CORP., 2124 EAST 12TH STREET, KANSAS CITY, MO 64124**, hereinafter referred to as "Contractor."

WITNESSETH:

WHEREAS, County solicited proposals for an Employment Barriers Program, pursuant to Request for Proposals 17-16; and,

WHEREAS, County and Contractor entered into an Agreement related to this program dated June 21, 2016; and,

WHEREAS, the initial Agreement was extended for an additional twelve-month term, pursuant to the First Addendum dated March 29, 2017, at an additional cost to the County in the amount of \$76,000.00; and,

WHEREAS, the parties now desire to increase the maximum sum to cover the costs of additional clients receiving re-entry services; and,

WHEREAS, this Second Addendum is authorized by Resolution 19589, dated October 2, 2017;

NOW, THEREFORE, in consideration of the foregoing and the terms and provisions herein contained, County and Contractor respectively agree with each other as follows:

1. Except as expressly provided herein, all provisions of the Agreement between Contractor and County shall remain in full force and effect.

2. The maximum sum to be paid by County to Contractor for 2017 shall be increased by the amount of \$34,200.00, for a maximum total of \$186,200.00.


