Greg Grounds moved to recommend for perfection Ordinance #3966, transferring \$16,457.00 within and appropriating \$164,581.00 from the unappropriated surplus of the 2008 Anti-Drug Sales Tax Fund in acceptance of a grant from the Missouri Department of Public Safety, and authorizing the County Executive to execute Cooperative Agreements with Arts Tech and Deana Bellamaganya for the Prosecuting Attorney's Office's Sentenced to the Arts program, at an aggregate cost to the County not to exceed \$164,581.00.
