5 COMMUNICATIONS AND REPORTS OF THE COUNTY EXECUTIVE

Katheryn Shields, County Executive, presented a 10 year service pin to Russell Hay, a commercial appraiser in the Assessment Department.

Victor E. Callahan, Chairman, asked the County Executive to explain the professional services contract for diversity training.

Katheryn Shields said she awarded a contract to Southern Christian Leadership Conference for diversity training. It consists of four sessions for approximately 20 department heads/assistant department heads that will cost a total of \$12,000.00. This cost will be paid for out of the County Executive budget. She agreed to provide a copy of the contract and a list of participants to the members of the Legislature.

Dixie M. Flynn, County Legislator, said that if broken down it comes to \$187.50 per hour which she feels is excessive.

Katheryn Shields responded that it also includes transportation, lunch and materials for the conference.

Victor E. Callahan asked who is the representative from Southern Christian Leadership Conference. Katheryn Shields responded Reverand Thompson.

Lisa White Hardwick, County Legislator, said that she does not feel it is excessive. She went out for bid for her law firm and some bids were as high as \$250.00 per hour for diversity training classes.

Dixie M. Flynn asked the County Executive if she was resubmitting the name of Mary Therese Carroll to the Plan Commission.

Katheryn Shields said that she will not be resubmitting her name. Under Missouri state law, she will continue to serve until a replacement is appointed.

Victor E. Callahan said according to Section 81.01 of the Jackson County Code, four members of the Plan Commission should reside in the unincorporated area. He urged Katheryn Shields to appoint a woman from the unincorporated area. He said there are only six members currently serving on the Plan Commission, which leaves three vacancies.

Katheryn Shields welcomed County Legislators to submit names of people interested in serving.

Discussion regarding the Plan Commission and the Southern Christian Leadership Conference contract.

Dixie M. Flynn asked the Administration if they addressed the complaint from the Prosecutor's Office concerning Woodley Building Maintenance.

Katheryn Shields responded that overall complaints are down on the terms of the contract.
