<p>REQUEST SUMMARY</p>	<p>October 28, 2010 Missouri Highways and Transportation Commission executed an Agreement with Jackson County to provide funding for the Safe Routes to School Program for the Hickman Mills School District. This Sheriff's Office requested the \$25,000.00 funds intended for the reimbursement of overtime used for neighborhood assessment, Safety presentations, data tracking, and ticketing traffic violations within a two (2) mile radius of the Dobbs, Ingles, and Johnson Elementary Schools. To provide high visibility enforcement and to educate students, neighbors and parents about traffic safety for cars, cyclist and pedestrians. At the end of the 2010 agreement, December 2012, there remained a balance \$15,436.94.</p> <p>This Resolution will extend the term of the grant through June 2014.</p>
