REQUEST SUMMARY	The Department of Corrections is freezing four Correctional Officer positions in the 001-2701 funds (EP073; EP035; EP207 and EP170) in order to transfer and utilize Regular Salary and FICA funds covering costs for three contract Security Officers from Homeland Security Services. Funding will cover contract services from Febrauary 27, 2017 through December 31, 2017. Current staffing shortages impede the ability to efficiently deal with security responsibilities. These contract services will initially support security needs related to major facilities maintenance and repair projects that are scheduled in 2017. In addition, contract Security Officers will be utilized in several areas as outlined in Bid No 3-16 and approved via Legislative Resolution 19142 in May, 2016.
