<p>REQUEST SUMMARY</p>	<p>This ordinance authorizes the County Executive to enter into a First Amendment to the Cooperative Agreement between Jackson County and Lee's Summit, Missouri. The original Cooperative Agreement authorized Lee's Summit to remove the Rock Island Trail Arch Tunnel over Chipman Road as a part of the City's project to widen the road, and provided funds from Lee's Summit to Jackson County to replace the structure with a pedestrian bridge as well as a freight or transit bridge in the amount of \$2,000,000.</p> <p>The City is now proceeding with the road widening project, and there are advantages to the County in working with the City to complete the replacement of the Rock Island Trail bridge concurrently with the road work. Through this First Amendment, the County agrees to reimburse the City for the design and engineering of the new pedestrian bridge, to be done by Wilson and Company in concurrence with the design and engineering for the road widening project. Wilson and Company were selected by the City for this project through a competitive selection process.</p> <p>Once designed, the pedestrian bridge will be bid as an alternate to Lee's Summit's project. If bids are acceptable, the County will be responsible for paying only for the construction of the pedestrian bridge. This action, if deemed favorable to the County, would come before the Legislature as the Second Amendment to the Cooperative Agreement.</p>
