SUMMARY: WHEREAS, the County owns parcels of property in Jackson County located in Kansas City, MO, Independence, MO, and Lee's Summit, MO; and, WHEREAS, the parcels numbers associated with these properties are as follows: Parcel #26-230-03-02 / 215 N. Liberty, Independence, MO / Jackson County Election Board building Parcel #43900-03-1101, 301 NW Gregory, Lee's Summit, MO / Hilltop Residential Center Parcel #29-340-07-01, 1300 N. Pennsylvania, Kansas City, MO / north parking lot for former Kansas City Sports Commission building Parcel #29-340-07-04, 1308 N. Pennsylvania, Kansas City, MO / former Kansas City Sports Commission building Parcel #26-230-30-02, 301 S. Liberty, Independence, MO / empty lot Parcel #26-230-30-03, 301 S. Liberty, Independence, MO / empty lot Parcel #26-230-30-04, 301 S. Liberty, Independence, MO / empty lot Parcel #26-230-30-05, 301 S. Liberty, Independence, MO / empty lot; and, WHEREAS, the Administration can identify no current or future use for the property; and,

WHEREAS, the Administration recommends that the Legislature declare this real property surplus to the County's needs and authorizes the Interim Director of Finance and Purchasing to solicit bids to sell the surplus property for the maximum benefit to Jackson County residents, pursuant to the provisions of Chapter 11 of the Jackson County Code 1984; now therefore, BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the parcel detailed above be and hereby is declared surplus and that the Interim Director of Finance and Purchasing be and hereby is authorized to solicit bids for the selling of the surplus parcel pursuant to the provisions of Chapter 11, Jackson County Code, 1984.
