Dan Tarwater III, Chairman, called the meeting of the Jackson County Legislature to order.

1 ROLL CALL

2 THE PLEDGE OF ALLEGIANCE

3 APPROVAL OF THE JOURNAL OF THE PREVIOUS MEETING

A motion was made by Scott Burnett, seconded by Charlie Franklin to approve the journal of the previous meeting held on September 13, 2021. The motion passed by a voice vote.

4 HEARINGS

Dan Tarwater III, County Legislator, opened the public hearing regarding Ordinances #5540, #5541, #5542, and #5543, setting the 2021 merchants' and manufacturers' inventory replacement tax levy, the Jackson County, Missouri tax levy, the Jackson County Board of Services for the Developmentally Disabled Levy, and the Jackson County Community Mental Health Fund Levy.

Representing the Jackson County Board of Services for the Developmentally Disabled were Jake Jacobs, Executive Director, Tedi Rowland, Vice Chairman, John Fierro, CEO of Mattie Rhodes Center, Lauren Hall, Executive Director of Southeast Enterprises, Amy Castillo, CEO of Ability KC, and Brian Hogan, Director of Blue Valley Industries, all speaking in support of Ordinance #5542, setting the 2021 Jackson County Board of Services for the Developmentally Disabled (Sheltered Workshop) Levy.

Representing the Jackson County Community Mental Health Fund were Dr. Bruce Eddy, Executive Director, Kristina Jones, Vice President of CAPA, Jennifer Craig, President and CEO of ReDiscover, and Rochelle Parker, President and CEO of CAPA, all speaking in support of Ordinance #5543, setting the 2021 Jackson County Community Mental Health Fund Levy.

John Gordon, Treasurer, Jackson County Department of Finance, said the 2021 tax levies as calculated are sufficient to meet the budgetary needs of the County. The 2021 rates include a recoupment rate in the General Fund. The assessed value in 2019 dropped after the 2019 levies were set, resulting in a \$1.6 million loss in revenue to the County. In addition, the recoupment rate was calculated for the Board of Services for the Developmentally Disabled and the Mental Health Fund tax levies for the 2019 tax year. Overall, for 2021 the assessed values have gone up which resulted in a reduced tax levy for 2021.

Scott Burnett, County Legislator, asked if there is the ability to increase the tax levies for the Board of Services for the Developmentally Disabled and the Mental Health Fund. Mr. Gordon said a recoupment rate could also be calculated for the 2020 tax year. This will require a floor amendment for the two ordinances.

Dan Tarwater III said this is the Legislature's intent. The ordinances will be held for amendments next week.

Jeanie Lauer, County Legislator, asked Troy Schulte, County Administrator, if the funds the County received from the American Rescue Plan could be used to give a one-time allocation to recover some revenue lost due to the pandemic. Troy Schulte said yes.

Ronald E. Finley, County Legislator, said it was his understanding the tax levies for the Developmentally Disabled and Mental Health Funds included a recoupment. Mr. Gordon said the introduced tax levy ordinances include a recoupment for 2019. This is due to the Board of Equalization appeals from the 2019 reassessment.

Dan Tarwater III closed the public hearing.

Ronald E. Finley asked for a moment of silence in remembrance of Officer Blaize Madrid-Evans of the Independence Police Department, who was killed in the line of duty on September 15, 2021.

5 COMMUNICATIONS WITH AND REPORTS OF THE COUNTY EXECUTIVE

Frank White, Jr., County Executive, introduced Dr. Jannette
Berkley-Patton, project leader of Our Healthy KC Eastside, Reverend Eric
Williams, pastor of Calvary Temple Baptist Church, and Niki Lee Donawa,
Chief Community Relations Officer for Truman Medical Centers, to give
an update on the Our Healthy KC Eastside project.

Our Healthy KC Eastside (OHKCE) is a community-wide initiative that promotes and delivers widespread COVID-19 vaccinations and other health services to residents on the east side of Kansas City. More than 60 community organizations and health agencies are partnering with OHKCE to support healthy lifestyles through vaccine events and health screenings like blood pressure checks, diabetes screenings and dental education.

Rev. Williams said this project pools resources from many entities, including faith-based organizations, business entities, neighborhood groups, the University of Missouri – Kansas City, and Jackson County, working collaboratively toward health measures in the community. This program plants seeds, not just for COVID related concerns, but also other health issues such as diabetes, mental health, and other chronic illnesses.

Ms. Donawa said this is an opportunity for Truman Medical Center to have outreach in the community to meet people on the front line.

Ronald E. Finley said he hopes this program can be continued after the pandemic to continue these positive responses, interactions and accomplishments.
