

CONSULTING SERVICES AGREEMENT

AN AGREEMENT, made and entered into on this 15th day of NOVEMBER 2018, by and between **JACKSON COUNTY, MISSOURI**, a Constitutional Home Rule Charter County, hereinafter called "the County" and the Curators of the University of Missouri d/b/a Center for Nonprofit Leadership, 5100 Rockhill Rd., Kansas City, MO 64110-2499, hereinafter called "Consultant."

WITNESSETH:

WHEREAS, the County and Consultant desire to enter into an Agreement whereby Consultant shall provide services as the facilitator for the interview process for the County's COMBAT director position, in accordance with the terms and conditions set forth in this Agreement; and,

WHEREAS, the County deems it to be in the best interest of its citizenry to support this Agreement;

NOW THEREFORE, in consideration of the foregoing and the terms and provisions herein contained, the County and Consultant respectively promise, covenant, and agree with each other as follows:

1. **Services To Be Provided.** Consultant shall provide services as the facilitator of the County's interview process for its COMBAT director position, and such other services as upon which the parties may mutually agree.

2. **Terms of Payment.** The County agrees to pay the amount of \$2,500.00 to Consultant for the services specified in this Agreement. Consultant shall be paid upon the County's receipt of Consultants invoice, at the conclusion of the interview process.



3. **Conflict of Interest.** Consultant warrants that no officer or employee of the County, whether elected or appointed, shall in any manner whatsoever be interested in or receive any benefit from the profits or emoluments of this contract.

4. **Duration.** This Agreement shall be effective as of October 15, 2018, and shall terminate on October 31, 2018.

5. **Severability.** If any covenant or other provision of this Agreement is invalid, or incapable of being enforced, by reasons of any rule of law or public policy, all other conditions and provisions of this Agreement shall nevertheless remain in full force and effect and no covenant or provision shall be deemed dependent upon any other covenant or provision unless so expressed herein.

6. **Liability and Indemnification.** No party to this Agreement shall assume any liability for the acts of any other party to this Agreement, its officers, employees or agents.

7. **Incorporation.** This Agreement incorporates the entire understanding and agreement of the parties.
