REQUEST SUMMARY	<p>Requesting a contract in the amount of \$21,000 with the National Center for Fathering. The National Center for Fathering will provide the Jackson County Family Support Division the following training services at the Pioneer Campus of Penn Valley Community College:</p> <p>2015 Fathering classes (Four - 6 week sessions and 1 - 4 week Saturday session); If requested a Women's Training class will be substituted.</p> <p>Program Expenses: All out-of-pocket costs for program materials, instructors, meeting costs, facility rentals, assessments, office supplies, transportation and recognition items are included.</p> <p>The National Center for Fathering (NCF) was selected to provide fathering training to the participants of Fathering/Child Support Court for a number of reasons: First, they are respected nationally and internationally as the leading father training organization, reaching more than 5,000 fathers in face-to-face training each year. Second, they have 25 years of experience as source of research-based fathering training in the Kansas City area. Third, NCF is the author and developer of the Quenching the Father Thirst curriculum that has been integral to the success of Fathering/Child Support Court to date. Fourth, their staff have been key contributors to the Fathering/Child Support Court and the instructors of the required fathering class since its inception in 1998.</p> <p>The effective period of this agreement is April 15, 2015 thru December 31, 2015.</p>
