WHEREAS, several cities within Jackson County have implemented the same system, thereby providing the Sheriff's Office with the opportunity to share and access critical data hosted by the vendor; and,

WHEREAS, pursuant to section 1030.4 of the Jackson County Code, the Director of Finance and the Purchasing recommend the award of a contract for the furnishing of a subscription for a license plate recognition camera system for use by the Sheriff's Office to Flock Group, Inc. dba Flock Safety of Atlanta, GA under OMNIA Partners - Region 4 Contract No. R250203, an existing competitively bid government contract; and,
