Theresa Galvin, Chair, called the meeting of the Jackson County Legislature to order.

1 ROLL CALL

2 THE PLEDGE OF ALLEGIANCE

3 APPROVAL OF THE JOURNAL OF THE PREVIOUS MEETING

A motion was made by Jalen Anderson, seconded by Scott Burnett to approve the journal of the previous meeting held on June 12, 2019. The motion passed by a voice vote.

4 HEARINGS

Theresa Galvin, Chair, presented Barbara Casamento with her 35 year pin.

Theresa Galvin asked Gail McCann Beatty, Director of Assessment, to address additional questions related to the informal review process. Scott Burnett, County Legislator, said that he assisted constituents with their appeals. He said he is worried about the June 28th deadline.

Ms. Beatty said that the July 24th deadline for the informal review process is not state-mandated but that the Board of Equalization deadline date of July 8th is state-mandated. She is encouraging taxpayers that are filing for a last-minute informal appeal to go ahead and file an appeal with the BOE to preserve their rights. She said she would work with Melinda Taylor in the BOE office to see if they can streamline the process so taxpayers will not have to do two separate appeals. She said that so far, they have had 5,200 informal appeals, about 1.7% of parcels. They do expect to receive more

appeals.

Ms. Beatty said that all timely filed appeals to the BOE will be heard. She said that we buy our houses as investments with the hope that it will increase in value. Her responsibility is to determine the market value of the properties within Jackson County. An increase in value will not necessarily result in an increase in taxes because the tax levy will vary by jurisdiction.

Ed Stoll, Chief Administrative Officer, reported that all jurisdictions except the Kansas City, Missouri School District, must adjust their tax levy values because of the Hancock Amendment. The Kansas City school board sets the tax levy for that jurisdiction and they are not required to abide by the limitations of the Hancock Amendment, but may roll back KCSD tax levy. Jackson County provides an estimate of the aggregate assessed values early in the year that the taxing jurisdictions use to calculate the non-binding tax levy rates. In September, the Assessment Department will issue its certified aggregate assessed values that the taxing jurisdictions will use to issue their binding tax levies that will be used to generate tax bills.
