Born in 1952 in Independence, Missouri, Mr. De Hardt is a lifelong area resident and currently lives in Kansas City, Missouri. He graduated from Van Horn High School in 1970, attended Washington University in St. Louis, Missouri, and graduated from Rockhurst College in Kansas City, receiving a Bachelor of Science in Business Administration in 1974. He attended the University of Missouri-Kansas City School of Law and received a Juris Doctor in 1977. He has actively practiced law since 1977 before the Courts of the State of Missouri, the Missouri Court of Appeals-Western District, the United States Federal District Court for the Western District of Missouri and the United States Court of Appeals for the Eighth Circuit. He is a former Jackson County, Missouri, Assistant Prosecuting Attorney and Assistant Public Defender. Mr. DeHardt is currently a shareholder in the firm of McQuain, DeHardt & Rosenbloom, P.C. and a partner in the Madison Law Building.

Mr. De Hardt represents individuals in matters involving federal and state criminal defense, including death penalty defense; personal injury, medical negligence, wrongful death and workers' compensation claims; traffic and DWI defense; dissolution of marriage and custody litigation; and in defense of civil claims. Mr. DeHardt has an active mediation practice handling domestic relation and federal and state civil matters.
