REQUEST SUMMARY	<p>Environmental Health has participated in the Regional HHW program for the previous 20 years. The Regional HHW Program allows the residents of unincorporated Jackson County to utilize the Kansas City and Lee’s Summit permanent facilities when disposing of household hazardous waste as well as the dozen or so mobile events held throughout the metro area. The county will work to successfully and safely dispose of various household waste materials. The staff of MARC, along with the MARC Solid Waste Management Districts participating communities provide for the size, type and selection of the mobile events.</p> <p>This request is to Execute an Intergovernmental Agreement with MARC Solid Waste Management District to participate in the Regional Household Hazardous Waste Center at a cost not to exceed \$24,629.26 in 2021.</p>
