**TITLE:** A Resolution Awarding a twelve (12) month contract with three (3) twelve month options to extend for the furnishing of Temporary Personal Services for use by Various Departments to AList Professionals of Olathe, Kansas, Emploi Group (DBA AtWork Personnel Services) of Sante Fe Springs, California, Miscellaneous Janitorial Services (DBA Staffing Services) of Kansas City, Missouri, and Penmac Staffing Services, Inc. of Lees Summit, Missouri as a split award under the terms and conditions of Request for Proposal 25-007.

**SUMMARY:** Various County Departments require a Term and Supply Contract for the furnishing of Temporary Personnel Staffing. The Purchasing Department issued Request for Proposal 25-007 in response to those requirements. A total of 1551 notifications were distributed and 32 responses were received and evaluated. Pursuant to Section 1054.6 of the Jackson County Code, the Director of Finance and Purchasing recommends a split award for Temporary Personnel Staffing to AList Professionals of Olathe, KS, Emploi Group (DBA AtWork Personnel Services) of Sante Fe Springs, California, Miscellaneous Janitorial Services (DBA Staffing Services) of Kansas City, Missouri, and Penmac Staffing Services, Inc of Lees Summit, Missouri as the lowest and best bids meeting specifications. This award is made as an "As Needed" basis and does not obligate Jackson County to

pay any specific amount. The availability of funds for specific purchases is subject to annual appropriations. The estimated annual spend through various departments is \$100,000.
