REQUEST SUMMARY	<p>The Federal Communication Commission (FCC) regulations require that all public safety radio systems must convert to a narrow-band system.</p> <p>The Metropolitan Area Regional Radio System (MARRS) complies with the federal narrow-banding requirements; and is part of an overall interoperability project underway for the region.</p> <p>The Subscriber Agency Agreement provides that the Subscriber Agencies, upon joining the Eastern Jackson County P25 Radio System, shall share with the City of Independence in the actual and anticipated costs for the utilization and ongoing maintenance of the Eastern Jackson County P25 Radio System and related infrastructure.</p> <p>By participating in MARRS, the Sheriff's Office and Parks + Rec Rangers will have full radio coverage in the eastern part of the county.</p> <p>The County's subscriber fee will commence effective January 1, 2017 at annual cost not to exceed \$60,895.</p>
