An ordinance enacting chapter 39, Jackson County Code, 1984, to be titled "Public Health," consisting of thirteen sections, with a penalty provision.

Request Summary
<p>Authorized by article VII, section 18(c) of the Missouri Constitution, article II, section 16.30 of the Jackson County Charter empowers the Legislature to enact ordinances "to protect and promote" public health. A recent court ruling has called into question the State of Missouri's public health statutory and regulatory schemes that have previously constituted the authority for public health orders issued by the Jackson County Health Department and administration. It is now in the best interests of the health, safety, and welfare of the citizens of Jackson County that the Legislature adopt its own Ordinance establishing a public health protection and enforcement framework, independent of state statutes and regulations, for the protection of the County's citizens.</p> <p>Crystal Williams will sponsor.</p>
