Bob Spence, County Legislator, said that Resolution #13025 is one of the outside agency appropriations that he doesn't understand. He does not feel it is the County 's business to rehab cities in Jackson County especially when it only applies to one section of one city. This is the third year for this program. It is an inappropriate use of taxpayers money to appropriate the \$95,000.00 again especially when the latest report from the Personnel Department indicates that there are 42 jobs available in Jackson County. Two positions consistently have ten or more openings and those positions are corrections officers and a light equipment operator. Corrections officers make \$11.00 per hour, which he realizes is a 10% increase from the prior year, however he would not want to guard prisoners for \$11.00 per hour. A light equipment operator earns \$7.97 per hour and they can earn twice as much or more in today's market. Jackson County will be hard pressed to ever fill these positions. He sincerely feels that we should not be spending this type of money when the County can't afford to pay its employees a living wage. He urges a "No" vote on this resolution.

Ronald E. Finley, County Legislator, said Mr. Spence may remember that as part of the budget at the recommendation of the staff and after an extensive and impressive detailed report by Mr. Kelly, the Legislature and Administration allocated some \$600,000.00 in a program in this year's budget to give a 10% increase to correctional officers in an attempt to remedy the problem and also to embark upon a program to upgrade the position and determine why we have the openings in corrections and to try to come up with solutions. In addition there are items in the budget to give merit increases and pay increases to bring people up to the minimums in the market. Last year, the Legislature was responsible in utilizing the budget to try to remedy the issues regarding the living wage of our employees. there is also a great deal that we have to do as far as services for the people of Jackson County which includes the people of the Northeast area in Kansas City. On that basis, he urged passage of resolution #13025 because budget hearings were held on this matter and Jackson County is being proactive in the personnel area.
