Dennis Waits moved to approve the Floor Amendment dated August 26, 2013, to insert the words "dated August 26, 2013," after the acronym "(MOU)" and the word "Overview" in the fourth paragraph on page two; to insert the words ",including expanding the research currently being performed on illnesses that affect the minority community in Jackson County," after the word "nation" in the second paragraph on page three; to insert paragraph three on page three to read "WHEREAS, to ensure equal access for Jackson County residents to all jobs, notices will be posted throughout Jackson County, including publication in such publications and with organizations as the Jackson County Advocate, the Independence Examiner, the Lee's Summit Journal, the Call, the Globe, Dos Mundos, the Hispanic News, the Urban League of Greater Kansas City, the Black Health Care Coalition, and St. Mark Child and Family Development Center; and,"; to insert paragraph four on page four to read "WHEREAS, all appointees to boards and commissions created pursuant to this initiative, with the exception of the Translational Medicine Institute Board of Directors and Scientific Advisory Board, shall be Jackson County residents; and,"; to insert paragraph one on page four to read "WHEREAS, the use of the County's 20% "carried interest," referred to in the Memorandum of Understanding and Overview, shall be subject to approval by the County Legislature for the purposes specified in the MOU and other lawful purposes; and," to insert the words ", including the reimbursement to the County for the costs of the election out of the proceeds from the first quarter collected." after the word "institute" in the final sentence of Section 2. on page five; to delete the word "and" after the words "Missouri-Kansas City," and to insert the words "and Jackson County" after the word "Institute", to insert the words "create healthcare related jobs in the County and" after the word "would", to insert the word "human" after the word "for" and to delete the words "and create healthcare related jobs in the County" after the word "diseases" all in the official ballot language on page five; to insert a final paragraph on page 6 to read "Section 6. The County Executive is hereby authorized to execute, on behalf of Jackson County, the attached Memorandum of Understanding (MOU) so that Jackson County is made a full party to the MOU. The activities of the Jackson County Translational Medicine Institute shall be governed by the Missouri open meetings laws, as well as Jackson County Fair Share policies." The Proposed Floor Amendment for the MOU and Operational and Governance Overview were also approved. Seconded by James D. Tindall.
