Scope of Work

Scope Statement:

Siemens has been asked to correct various issues on the existing Siemens MXL fire alarm system. The MXL system is no longer in production and parts are no longer available. However, The system can be migrated over to the Siemens Desigo Modular system.

This migration will utilize the existing FACP backbox, cabling and field devices.

Siemens conducted a site visit to visual inspect the system and retrieve the history from the MXL system. Siemens found many devices not responding, faulty batteries in the FACP and the audible power panels. Siemens also witnessed an intermittent ground fault condition, and an open circuit on one of the audible power panels.

Siemens strongly suggest the migration of the existing FACP, Remote Annunciator and the smoke control panel (located on the upper level master control room), replacement of all batteries in the FACP and audible power panels.

This proposal has been revised to change the address and update the proposal date.
