WHEREAS, Corwin Motors of Springfield, MO and Corwin Ford Lincoln Republic of Republic, MO responded with off the lot quotes for all four requested vehicles; and,

WHEREAS, pursuant to section 1030.4 of the Jackson County Code, the Officer in Charge of the Task Force and Director of Finance and Purchasing recommend the award of a contract for the furnishing of four new vehicles for use by the Drug Task Force to Corwin Motors of Springfield, MO and Corwin Ford Lincoln Republic of Republic, MO under the terms and conditions of an existing competitively bid state of Missouri Contract No. CC240138001-011, at an actual total cost to the County in the amount of \$196,134.00; and,

WHEREAS, award under the state contract is recommended due to the significant discounts offered to larger entities; now therefore,


