

ADDENDUM TO AGREEMENT

THIS ADDENDUM TO AGREEMENT, by and between **JACKSON COUNTY, MISSOURI**, hereinafter referred to as "**the County**," and **MATTIE RHODES CENTER**, 1740 Jefferson, Kansas City, MO 64108, a Missouri not-for-profit corporation, hereinafter referred to as "**Organization**," is made and entered into this 24 day of February, 2011.

WITNESSETH:

WHEREAS, by Resolution 17141, dated January 19, 2010, the County and Organization did enter into an agreement whereby Organization agreed to provide drug prevention services, at a cost to the County of \$73,131.00; and,

WHEREAS, the Jackson County Drug Commission has recommended an extension to the agreement for 2010 drug prevention services, at no additional cost to the County; and,

WHEREAS, by Resolution 17470, dated January 18, 2011, the County Legislature has authorized the County Executive to enter into this Addendum to Agreement;

NOW THEREFORE, in consideration of the mutual covenants and promises herein contained, County and Organization do hereby additionally agree as follow:

1. Except as hereinafter specifically modified, all of the terms of the prior Agreement between the parties dated March 2, 2010, shall remain in full force and effect and the terms and conditions thereof are incorporated herein by reference.


3. This Addendum to Agreement shall be effective as of December 31, 2010

and shall extend, with the original Agreement, through April 30, 2011.


4. This Addendum, together with the Agreement dated March 2, 2010, incorporates the entire understanding and agreement of the parties.


