TITLE: Authorizing a six (6) month extension to a Term and Supply contract for the furnishing of Fuel Products and Related Services for use by various County Departments to Frazier Oil & L.P. Gas Co., Inc of Gower, Missouri, awarded under the terms and conditions for City of Kansas City, Missouri Contract No. EV1848, an existing government contract.

**SUMMARY:** The initial expiration date of the City of Kansas City, MO Contract No. EV1848 was April 30, 2024, but the City of Kansas City, Missouri extended the contract for an additional 12 months effective May 1, 2024 with an expiration date of April 30, 2025. There was a serious delay in getting this information from the City of Kansas City, Missouri due to them recovering from their own cyberattack earlier in the year. Pursuant to Section 1030.4 of the Jackson County Code, the Director of Finance and Purchasing recommends the approval of a six (6) month extension for the furnishing of Fuel Products & Related Services to Frazier Oil, Inc of Gower, Missouri under the Terms and Conditions of the City of Kansas City, Missouri Contract No. EV1848, an existing cooperative government contract. The estimated six (6) month annual usage is \$378,000. This award is made on
