**AN ORDINANCE** appropriating \$69,345.00 from the undesignated fund balance of the 2024 Grant Fund, in acceptance of a three-month extension of the VOCA Grant awarded to the Jackson County Prosecutor's Office by the Missouri Department of Social Services.

**ORDINANCE NO. 5890**, October 7, 2024

**INTRODUCED BY** Donna Peyton, County Legislator

WHEREAS, by Ordinance 5058, dated November 28, 2017, the Legislature did authorize the execution of a program agreement with the Missouri Department of Social Services for the Victims of Crime Act (VOCA) grant; and,

WHEREAS, by Ordinance 5808, dated November 6, 2023, the Legislature did grant an extension of the program agreement with the Missouri Department of Social Services for the VOCA grant; and,

WHEREAS, the Prosecuting Attorney is requesting a three-month extension of the VOCA grant that was awarded to the County by the Missouri Department of Social Services with a grant term of October 1, 2024 to December 31, 2024; and,

WHEREAS, this extension will provide for continued funding for the salaries of six victim advocates through the expiration date of December 31, 2024; and,

WHEREAS, the Prosecutor's Office will provide an additional \$26,413.00 for the unfunded portion of the salaries of the incumbents; and,

WHEREAS, an appropriation is necessary in order to place the grant funds in the proper spending account; now therefore,

BE IT ORDAINED by the County Legislature of Jackson County, Missouri, that the following appropriation be made from the undesignated fund balance of the 2024 Grant Fund:
