**TITLE:** Award a contract for printing and mailing services for use by the Assessment Department to **OneSource** of Buffalo Grove, Illinois; as the lowest and best submission for RFP 24-053.

**SUMMARY:** The Assessment Department has an ongoing annual need to obtain printing and mailing services for a variety of needs throughout the entire department. Items that regularly need to be printed and mailed in bulk (tens of thousands, or even hundreds of thousands at a time) include; IPP Declarations, BPP Declarations, Reassessment Notices and Real Property Value Change Notices. The results of the publicly posted open bid process returned to us with three vendor submissions. We have seriously and meticulously considered each of these vendors. The vendor selected as the lowest and best submission is **OneSource** (onlyonesource.com/) of Buffalo Grove, Illinois 60089. It is apparent that **OneSource** has the experience, resources and customer service acumen to serve the current needs of the Assessment Department and to handle our scope of work regarding the printing and mailing services needed. Using **OneSource** as our vendor, we expect to have an estimated annual expenditure of \$100,000 for these printing and mailing services for the Assessment
