

Amendment #2 to the Software License and Related Professional Services Agreement between Woolpert, Inc., dba as Data Cloud Solutions, a Woolpert Company and Jackson County, Missouri

Section 1. General

THIS Amendment #2, made and entered into this 24th day of October, 2022, by and between Data Cloud Solutions, a Woolpert Company whose address is 1730 N. Limestone Street, Suite A, Springfield, OH 45503 (hereinafter referred to as "DCS") and Jackson County, Missouri, (hereinafter referred to as the "Customer"), provides for Changes under the Software License and Related Professional Services Agreement dated March 20, 2020, such Changes described under Section 2 of this Amendment.

Section 2. General Description of Services

The additional services to be provided to the Customer are identified below.

Continued SaaS hosting, maintenance, and support for up to 307,500 (from 299,500) real-estate parcels for the following CAMACloud modules migrated from the legacy CAMA system (Sigma, on Informix) to the new CAMA system (EnterpriseAssessment, on Oracle):

1. MobileAssessor: 34 mobile device (iPad) licenses,
2. Admin Console: 41 desktop (PC) device licenses, with access to upgraded modules as indicated below,
 - a. Desktop Review: 25 user licenses,
 - b. Sketch Validation: 20 user licenses,
 - c. Comparable Properties: 11 user licenses, and
 - d. Data Analyzer: 4 user licenses.

Section 3. Compensation

Compensation to be paid by the Customer to DCS shall be as follows:

SaaS hosting, annual maintenance, and support for the extension and optional renewal terms are as follows:

1. 1/1/2022 – 12/31/2022 = \$101,602.50
2. 1/1/2023 – 12/31/2023 = \$104,650.58
 - If not canceled by 11/1/2022
3. 1/1/2024 – 12/31/2024 = \$107,267.00
 - If not canceled by 11/1/2023
4. 1/1/2025 – 12/31/2025 = \$109,413.00
 - If not canceled by 11/1/2024



Section 4. Schedule for Services


