

**CONTRACT RENEWAL NO. 2  
TO INTERGOVERNMENTAL COOPERATIVE AGREEMENT  
BETWEEN  
JACKSON COUNTY, MISSOURI  
AND  
CITY OF KANSAS CITY, MISSOURI**

THIS CONTRACT AMENDMENT is between KANSAS CITY, MISSOURI, a constitutionally chartered municipal corporation ("City"), and Jackson County, Missouri ("County" or "Contractor"), whereby the parties desire to amend the parties' Agreement as follows:

WHEREAS, the City and County have an Agreement for the County to house up to 45 City inmates; and

WHEREAS, the Agreement and Contract Renewal No. 1 expires on September 30, 2020; and

WHEREAS, it is in the best interest of the City and County to extend the Agreement for an additional 180-day term;

NOW THEREFORE:

A. The City and County agree to amend the Agreement as follows:

**Sec. 6. Term of Contract:**

- A. **Initial Term of the Contract** is December 19, 2019, through March 31, 2020.
- B. **Renewal 1 of the Contract.** The second term of the Contract is from April 1, 2020 through September 30, 2020.
- C. **Renewal 2 of the Contract.** The third term of the Contract is from October 1, 2020 through March 31, 2021.
- D. **Renewal Terms.** The Parties shall have the mutual option of renewing this Agreement for additional terms of up to 180 days. Each such renewal option must be exercised in a writing signing by the appropriate official(s) of each Party, at least sixty days prior to the start of the renewal term unless this 60-day period is waived by the County. The Sheriff shall have the authority to exercise any renewal option of the County.
- D. **Early Termination for Public Health Emergency.** In the event of a public health emergency affecting the Jail, declared by a


competent authority, the County may immediately suspend its performance under this Agreement until such time as both parties are satisfied that the emergency no longer exists. In such event, the County shall give the City as much notice as is practicable of the need to relocate the City inmates, and the City's obligation to pay compensation to the County shall also be suspended.

B. **Sections not Amended.** All other sections and subsection of the Agreement shall remain in full force and effect.


