# 14 NEW BUSINESS

Bob Berkebile, an architect, distributed copies of Scientific American to all legislators. He said designs completed may have a different outcome on the users than intended. The question is if the designs improve human well being and vitality of the community. He spoke about global climate change, ozone depletion, air pollution, soil erosion and water pollution.

Katheryn Shields said Bob is a messenger of hope. She said the Scientific Panel in August 2005 reported to British Prime Minister Tony Blair that by the year 2010 if the industrialized world does not cut its release of carbons in half we will reach the tipping points in the oceans and ocean currents.

Katheryn Shields said that Clay County, Missouri started an effort for counties in the area to provide relief for Hurricane Katrina victims. She recognized Clay County for their leadership and thanked the County Legislature for appropriating approximately \$100,000.00 and allowing 19 employees to go to Louisiana to provide assistance.

Present from Clay County government were D.C. Rogers, Emergency Services Director, Alexa Barton, Assistant County Administrator and Leslie Enzine, Director of Human Relations. They thanked Jackson County for their cooperation and said they look forward to working with us in the future.

Katheryn Shields, Tom Phillips, Sheriff and Scott Morello, Safety Coordinator with the Public Works Department, talked about the Emergency Preparedness System for unincorporated Jackson County, Missouri.

Katheryn said the most important lesson learned from Katrina was that help will come from local government and they will be the first responders, not the federal or state government. She said Jackson County's emergency management plan was updated in 2004 and they will have draft changes for the County Legislature to approve. The Geographic Information Systems (GIS) Department will be included in the plan.

Rhonda Shoemaker, County Legislator, asked for a report on the status of the levies.

Scott Morello agreed to get the information regarding the levies from the Corps of Engineers.

Dan Tarwater, County Legislator, asked if the Jackson County Election Board employees were included in the raises.

Troy Thomas, Chief Financial Officer, said they were not included. He said he will contact the directors this week to discuss it.
