Request to extend the end date of the contract awarded to Tico Productions of Kansas City, Missouri, under the terms and conditions of the Request for Proposal (RFP) No 49-20, to December 31, 2024, for the purpose of fulfilling the deliverables commitment.

Request Summary

Project/Title:

The COMBAT Commission required a contract for rebranding services. The Purchasing Department issued RFPNo. 49-20 in response to the requirements. The COMBAT Commission and the Purchasing Department recommended awarding a twelve-month contract, with one (1) twelve-month option to extend for the furnishing of rebranding services.

In addition to the two prior extensions, the requested contract extension period is needed to provide Tico Productions of Kansas City, Missouri additional time to meet its deliverable obligations as outlined in Exhibit A of the contract (attached).

The total contract amount is \$33,000. In year 1 of this contract, \$17,300 was spent. It was anticipated that the extension periods in Years 2 and 3, authorized by R.20876 and R.21166, respectively, would have provided sufficient time for Tico to complete the remaining deliverables and invoice for the \$15,700 contract balance. Currently, the contract balance is still \$15,700.

Tico's delay in meeting the deliverables were due to the loss of several of its staff assigned to the COMBAT project.
