WHEREAS, Nick took over his father's barber shop, John's Barber Shop, nearly five years ago and through the barber shop has sponsored teams for Lee's Summit Baseball Association and Lee's Summit Soccer Association for many years; and,

WHEREAS, while a member of the City Council, Nick traveled with a group to Gulfport, Mississippi, to volunteer in Hurricane Katrina relief; and,

WHEREAS, it is through Nick's inspiration that many throughout the Lee's Summit community have been motivated to join in his unique fundraising efforts; now therefore,
