

FIRST ADDENDUM  
TO AGREEMENT

THIS FIRST ADDENDUM made this 7<sup>th</sup> day of July, 2017,  
by and between JACKSON COUNTY, MISSOURI, (hereinafter called "County") and FIRST  
CALL ALCOHOL/DRUG PREVENTION & RECOVERY, INC., 9091 State Line Road,  
Kansas City, MO 64114, hereinafter called "First Call."

WITNESSETH:

WHEREAS, by Resolution 19188, dated June 20, 2016, the Legislature did award a  
six-month contract with three twelve-month options to extend to First Call to provide  
software maintenance and support for the substance abuse treatment data tool, COMBAT  
~ Connections, as a sole source purchase, at an annual cost to the County of \$39,000.00;  
and,

WHEREAS, the parties now desire to expand the scope of that Agreement at an  
additional cost to the County;

NOW, THEREFORE, in consideration of the foregoing and the terms and provisions  
herein contained, County and First Call respectively agree with each other as follows:

1. Except as expressly provided herein, all provisions of the Agreement dated  
August 9, 2016, between First Call and County shall remain in full force and effect.
2. The Scope of Services shall be amended to update the software and expand  
the software's reporting features.



3. First Call shall be paid for these services at the rates specified in Exhibits A and B, at an additional cost not to exceed \$11,400.00, to be paid upon the completion of this additional work.

4. This First Addendum shall be effective January 1, 2017, and shall extend until December 31, 2017.


5. This First Addendum, together with the Agreement dated August 9, 2016, incorporates the entire understanding and agreement of the parties.
