A RESOLUTION transferring \$50,050.00 within the 2012 Anti-Drug Sales Tax Fund to cover funding for the Sheriff's Office's 2012 Drug Abuse Resistance Education (DARE) program.

RESOLUTION #17984, September 24, 2012

INTRODUCED BY James D. Tindall, County Legislator

WHEREAS, by Resolution 17807, dated January 30, 2012, the Legislature did authorize the allocation of one-half of the budgeted Anti-Drug Sales Tax funds for the Sheriff's Office's 2012 Drug Abuse Resistance Education (DARE) program, and;

WHEREAS, the COMBAT Administration now recommends that the remaining balance of \$50,050.00 in the Sheriff's Office's Anti-Drug Sales Tax Fund be transferred to its 2012 DARE program; and,

WHEREAS, the County Executive has recommended said transfer; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the following transfer be made within the 2012 Anti-Drug Sales Tax Fund:

REQUEST SUMMARY	<p>A resolution authorizing the County Executive to transfer funds from the Anti-Drug Sales Tax Fund for the purpose of providing funding for the 2012 fiscal year, for the Drug Abuse Resistant Education (D.A.R.E.) and D.A.R.E. like prevention activities and purposes, not to exceed \$50,050.00. This proposed legislative action equals one-half of the D.A.R.E. allocation, for this the program this fiscal year and represents the 2nd payment.</p> <p>Exhibit A indicates the funding transfers for the Sheriff's Department for funding of the DARE services for the second half of fiscal year 2012, and transferring funds from the COMBAT DARE to various line items within the Sheriff's Department as recommended by the Jackson County Drug Commission for the 2012 fiscal year.</p> <p>Background: The Anti-Drug Sales Tax fund authorizes the County to execute agreements and contracted service for the purpose of providing substance abuse treatment, prevention, grant match, and other anti-drug initiatives in the community.</p> <p>Several meetings were conducted between COMBAT, DARE officers, and the respective Chief of Police of the various departments, during which several different funding allocations were examined and discussed. Final</p>												

	<p>consensus was reached that the funding allocation formula be based upon the number of students enrolled in the core classes (either 5th or 6th grade plus one middle school grade).</p> <p>Initial Funding recommendations were presented to the Jackson County Drug Commission on January 18, 2012.</p>
