WHEREAS, the Jackson County Family Court Division has been awarded a grant by the State of Missouri Office of State Courts Administrator in the amount of \$16,700.00, to provide funding for the Multimedia Website for Self-Represented Litigants project; and,

WHEREAS, the grant is awarded for the period of July 1, 2024, through June 30, 2025; and,

WHEREAS, an appropriation is necessary to place these grant funds in the appropriate spending accounts; now therefore,
